- The bidswill be opened in the presence of Bidders' representatives who choose to attend at [**2:00pm on 2076/01/03**] at the office of [**Bheri Municipality, Khalanga, Jajarkot**]. Bids must be valid for a period of [**90 days**] after bid opening and must be accompanied by a bid security amounting to a minimum of [**96,000/-**], which shall be valid for 30 days beyond the validity period.
